By signing this agreement, I give permission for my child to take dance lessons at Susie Karlik's Dance Sensation (SKDS) for the dance season beginning on September 8, 2020 and ending on June 19, 2021. I have read and agreed to all rules and policies, which is posted both in the studio and on the studio website (www.skdsensation.com). I understand that tuition is to be paid on the first class of each month of the dance season. I also acknowledge that a \$15.00 late fee will be applied to payments received after the 15th day of a particular month, and also that a \$25.00 returned check fee applies to all returned checks. I understand that tuition and costume fees are non-refundable and non-transferable. I also understand that tuition for the first month in which my child is enrolled at SKDS and June 2021 tuition shall be paid together as one payment. April 2021 and May 2021 tuition are due together by May 1, 2021. I also understand that if my account falls more than 60 days past due, SKDS will run the above credit card for the past due balance on my account. This applies to tuition, costumes and all fees. I also agree to the non-refundable recital/registration agreement and will pay \$50.00 per student or \$60.00 per family upon registration. This fee includes a recital download link of 2021 recital, recital t-shirt and registration fee. By Signing this agreement you agree to all the rules and guidelines signed in the 2020-2021 waiver.

For your convenience, SKDS offers an Easy Payment Plan. Monthly tuition will automatically be paid by using a debit or credit card with a VISA or MasterCard logo. On the 1st day of every month during the 10-month dance season, your debit / credit card will be automatically charged your monthly tuition rate. All costume fees will also be automatically charged to your account on the due date.
